### Maryland School Parent Notification Letter School Improvement (SI) Parent Option Letter

October 1, 2013

This notice is to provide information about requirements of the Elementary and Secondary Education Act (ESEA), formerly known as No Child Left Behind. The purpose of ESEA is to improve educational opportunities for all children attending a Title I school. This federally funded program provides assistance to schools serving students who are at risk for academic failure. This legislation supports school district's efforts to provide a strong standards-based educational program for students along with accountability for student achievement. Some low-performing schools will receive a federal label of either Focus or Priority, with Priority being the more critical of the two labels. The Washington Elementary School District has no schools identified as Priority. Additionally, Arizona law has its own accountability system that designates schools with a letter grade from A through F. This will help parents better understand how our schools are performing academically.

1. Our school's state label is: C
2. Our school's federal label is: Focus. This is due to the low performance of and gaps between certain sub-groups of students.

### **School Improvement Plan**

We have been working with the District and the Arizona Department of Education (ADE) to revise the Continuous Improvement Plan for Maryland. In order to address the indicators that led to our Focus status, the District and ADE are assisting this school in:

- Providing support in developing/revising our Continuous Improvement Plan (e.g., leadership mentoring, high-quality ongoing professional development, research-based interventions);
- Coordinating resources (e.g., instructional and non-instructional staff, state and federal funding); and
- Assisting with addressing families' needs and building a collaborative relationship with the school community.

The school has implemented the following strategies/programs to address the achievement of all students:


- Best First Instruction using the WESD RTI Roadmap framework to include collaborative lesson planning among teachers at grade levels to increase consistency in practice, ongoing measurement of outcomes, comparison of assessment data, and implementation of effective delivery of instruction in Reading and Math;
- Data analysis to address mastery of Reading and Math standards by all student subgroups;
- Response to Intervention that includes a multi-tiered instructional support system with students receiving 90 minutes of direct instruction in Tier 1 Reading including small group instruction and additional Tier 2 and/or 3 interventions for students needing additional intervention support;
- 21<sup>st</sup> Century after school classes to include targeted students needing intervention support; and
- Professional Development on an ongoing basis by math and literacy coaches to include modeling, collaborative planning, co-teaching, observation of peers and side-by-side coaching to provide support for purposeful and effective instruction in Reading and Math.

## Request to Transfer Schools

Your child’s school was identified as a school in need of improvement under Title I of the *No Child Left Behind Act of 2001*. As a result, you have the right to request that your child be transferred to a school that has not been identified as a school in need of improvement. The District will review all applications and will notify parents of the transfer approval and subsequent transportation schedule for the new school. Once a student has transferred to a school that is not in improvement, he/she can remain enrolled at that school until he/she completes the highest grade at that school. However, if the student’s original school improves and is no longer in school improvement, the District may discontinue transportation.
